

Terms

- **1.** All classroom instruction and fingerprinting will be provided at the office location at 1503 10th Ave., Port Huron, Mi. 48060.
- **2.** All basic control skills, road instruction, and Skills Test will be held at 1635 Washington Ave. Port Huron, Mi. 48060. Dedicated Driving School, LLC will conduct the behind-the-wheel instruction in a tractor-trailer that is fully insured to cover each student enrolled in the program.
- **3.** Program fees include: **Entry Level...** course materials, CLP test fee, fingerprinting, (for the Hazmat/Tanker program) and the cost of one road test with **Dedicated Driving School, LLC** including vehicle rental. **80/40-hr...**Test fee is not included. **Test Readiness** training does not include any extra costs.

The student is responsible for the cost of the license fee upon successful completion of the skills test, including any endorsements beyond the basic CDL-A minimum requirements, and all costs associated with subsequent CDL driver license tests.

NO REFUNDS WILL BE ISSUED DUE TO FAILURE OF THE FINGERPRINT BACKGROUND CHECK!

- **4.** A **non-refundable** deposit is required when this contract is signed, or when reserving training time. The deposit for the **Entry Level Programs** (day or evening) is **\$500.** Deposit for **weekly** training is **\$250,** and for the **Test Readiness Program** is **\$50.** Full payment of the program balance by cash, check, money order or debit/credit card must be made by the first day of training.
- **5.** All students **must** present a current **CLP** (Commercial Learner's Permit) prior to any behind-the-wheel instruction. Arrangements must be made through our office if you are obtaining the **CLP** through Dedicated Driving School, LLC.
- **6.** In the event that a training day is cancelled, a make-up day will be designated at the discretion of **Dedicated Driving School**, **LLC**, usually on the next available business day. **IF PHSD IS CLOSED, WE ARE CLOSED UNLESS OTHERWISE INDICATED.**
- **7.** One training session may be cancelled by the student, with 24 hours' notice, and will be made up at a time mutually agreed upon by the student and **Dedicated Driving School**, **LLC**. There is a **\$100** charge for a notice less than 24 hours.

REQUIREMENTS TO PASSING THE COURSE

1. To obtain a Certificate of Completion, a score of 90% GPA on each training segment (Classroom, Basic Control Skills (Range), & Road (BTW)) is required to pass the course. Certificates of Completion will be presented only to those who pass the course.
